REGISTRATION FEES

FINANCIAL ASSISTANCE

Exceptionally, a financial assistance may be obtained to partially cover the cost of registration fees. Applications <u>must be made when registering on the Foundation's website</u>.

All requests for financial assistance must be accompanied by all the necessary documents: résumé, copies of diplomas, a motivation letter and two letters of recommendation.

Applications for financial assistance are examined by the Director of the Foundation and the Director of Studies. The participant will be informed by e-mail of the outcome of his/her application. No appeal is possible.

No additional financial assistance can be obtained after the committee's decision.

Due to the very limited amount of financial assistance available from the Foundation, participants are strongly advised to contact governmental and intergovernmental agencies, international organisations, academic institutions, foundations or organisations and donors that are likely to provide them with financial assistance.

TERMS OF PAYMENT

Payment must be made on receipt of an automatic notification sent by e-mail only.

Registration fees can only be paid by credit card or PayPal online on the Foundation's secure website.

Bank charges are the responsibility of the participant.

CERTIFIED TRAINING ORGANISATION

TRAVEL AND VISA

We would like to draw your attention to the conditions to obtain a **short-stay Schengen visa** imposed by the consular authorities (further information is available on the France Visas website).

You should check **your eligibility** for a visa before registering to our Summer School. Due to lengthy processing, we recommend that you apply for your visa appointment as soon as possible. We recommend that you pay your registration fees as soon as possible, so as to receive your letter of admission, which you will need for your visa application to be processed.

The Foundation does not guarantee that your visa will be issued and cannot under any circumstances intervene in the procedure for obtaining it. All visa and travel costs are the responsibility of the participant.

In the event of cancellation due to the non-issuance of a visa, the registration fee will be refunded less the sum of 100 euros corresponding to the handling fee, on presentation of proof from the consular authorities confirming the visa refusal only. This request must be made within a reasonable time.

HEALTH/ACCIDENT INSURANCE

It is compulsory to take out personal insurance covering your health and repatriation costs for the duration of your stay in France. Under no circumstances will the Foundation cover medical or hospitalisation expenses. This insurance must be presented to the consular authorities when your visa application is examined.

TRAVEL AND ACCOMMODATION

ACCOMMODATION

 Accommodation in university hall of residence is offered to participants who request it when registering online on our website.

Please note that accommodation is booked from Saturday to Saturday.

Costs (Single room with private shower room)

- 450 euros (28-night)
- 300 euros (14-night)
- 200 euros (7-night)

All rooms booked must be paid for in full and are non-refundable for any reason whatsoever.

The Foundation is not responsible for any difficulties related to accommodation conditions, which are the responsibility of the people in charge of the hall of residence.



DIPLOMA IN INTERNATIONAL AND COMPARATIVE HUMAN RIGHTS LAW

The Diploma in international and comparative human rihts law is open to participants **enrolled in**Unit 1 (face-to-face) who already have a thorough knowledge of international and comparative human rights law.

Candidates will have to attend **prep seminars** for the Diploma, independent of Unit 1 courses and events.

Diploma examination is also independent of the Unit 1 exam.

DIPLOMA REGULATION

ARTICLE 1 Application/Accessibility

Each candidate must submit a complete application file on site on arrival on the first day of Unit 1.

This must include:

- Diploma registration form
- A curriculum vitae
- Any useful references (publications, proof of professional experience, letters of recommendations, etc.)

This Diploma is completely separate from the final exam designed to verify the general knowledge acquired during Unit 1 of the Summer School.

ARTICLE 2 Timetable

The programme for prep seminars will be given to the candidates during an information meeting for the Diploma, which will take place on the first day of Unit 1, **Monday 24 June 2024.**

The Diploma tests will take place in Strasbourg during the second week of Unit 1.

DIPLOMA REGULATION

ARTICLE 3 Process

1 - A written test

A written exercise lasting five hours.

Candidates will be able to choose between two subjects relating to international law and comparative human rights law.

Candidates must obtain a minimum mark of 12/20 to proceed to the second test.

2 - A practical case / Defence

A practical exercise involving the study of a case relating to the universal or regional systems of human rights protection: the United Nations Human Rights Committee; the Inter-American Court of Human Rights; the European Court of Human Rights; the African Commission on Human and Peoples' Rights.

Each candidate will have to **defend a case**, 24 hours after having drawn lots for a subject.

Candidates must obtain a minimum mark of 12/20 to be admitted to the final test.

3 - An oral presentation

A presentation in the form of a **lecture-discussion on a subject chosen at random**. The candidate will have 2 hours of preparation time without documentation. The subject will be about international human rights protection.

To be admitted, candidates must obtain a minimum mark of 12/20.

ARTICLE 4 Jury

The jury for the tests is composed of highly qualified and internationally recognised personalities.

DIPLOMA REGULATION

ARTICLE 5 Exceptional conditions

Exceptionally, if a candidate does not get the required average mark, but has distinguished himself/herself in the various tests, the jury may, at its discretion and without right to appeal, award the candidate **the distinction**"CUM LAUDE", which will give the candidate the opportunity to submit a dissertation in an attempt to obtain the Diploma.

Said dissertation must be sent to the Foundation by 31 March of the following year at the latest. The issuing of the Diploma is subject to the jury's assessment of the dissertation.

ARTICLE 6 Remedies

If a candidate fails one of the tests, he or she has the **right to appeal** within **30 days** following the publication of the results.

The appeal must take the form of a **letter**, addressed directly to **the Director of the Foundation**, and will present the elements or parts of the decision that are contested and the reasons for such a challenge.

It should be remembered that if a candidate fails the Diploma, he or she may retake it as many times as he or she wishes at subsequent Summer Schools.
